Web. 25 Mar. 2014. Ali Acilar works at Bilecik University, located in Bilecik, Turkey, as an assistant professor in the Department of Business Administration. The article begins by giving an overview into the history of Internet piracy and the lasting effects. Virginia Crisp is the Senior Lecturer in the Media Department at Middlesex University in London.
